Rain Date 2026: In case of inclement weather, the event will be held Saturday, October 3, 2026, at the same time and location. If both days are a washout, we will reschedule the event on the next available date in the Spring of 2027.

Guidelines, Rules and Regulations

1. You may reserve as many vendor spaces as you need.
2. Completed applications must be signed and mailed with a non-refundable check, or non-refundable Zelle payment along with the signed application.
3. Once we receive your application, you'll get an email confirmation along with any additional event details. You will be able to select whatever available space is open. If vendor spaces are already full, your application and check/Zelle will be returned to you.
4. This event is intended for individuals and families selling unwanted, gently used household items, furniture, toys, books, sporting goods, antiques, collectibles, and handmade arts or crafts. Personalized items are welcome. Representatives of nationally branded products or organizations are not permitted.
5. You must bring your own folding table(s). Your space size is approx. 12 ft x 12 ft. Tables may not exceed 9 feet (108 inches) in length. Failure to comply will result in forfeiture of your prepaid space as outlined in the application.

Guidelines, Rules and Regulations Continued

6. Tents are welcome this year, provided they do not extend beyond your designated area. Any violation will result in loss of space — no exceptions. Any tent damage to the grass will result in loss of \$20 security deposit per space.
7. We reserve the right to prohibit the sale of any items that do not meet event requirements or are deemed inappropriate.
8. Vendors are prohibited from selling animals, weapons (including guns, knives, swords, etc.), any items illegal to sell in New York State, and any products that could deface town property, such as spray paint or washable paints.
9. Vendor setup opens at 7:30 a.m. Early arrival is not permitted. We ask everyone to be considerate of the surrounding residential area.
10. Vendor Check in is required before unloading. Please provide your **\$20 cash security deposit per space** at the registration table and collect your welcome packet before dropping off items and moving your vehicle. We will not have change or a credit card machine to take the deposit.
11. Vendors should be completely set up 30 minutes prior to the start time of 10:00 a.m.
12. Vendors who arrive after 9 a.m. may be restricted from driving near the event area and should arrange to carry their items to their assigned space
13. Vendor vehicles are prohibited in the event area during the event. All vehicles must be removed from the event area by 9:30 a.m. You will receive a parking pass at check-in and may park across the street at the Leo Mintzer Center Lot (251 Underhill Ave, West Harrison, NY 10604). Please do not use street parking or town-center spaces — those are for your shoppers!
14. Vendors may not pack up before the official end time. Vehicles will only be allowed back into the event area once the event coordinator confirms it is safe.
15. Vendors should bring their own hand truck or dolly, as none will be available on site.
16. Please make sure all items are in working condition; NO electricity will be available on site to test appliances/electronics.
17. There are NO electrical hook ups allowed. Be sure to check all appliances/electronics at home prior to the sale. Generators are prohibited.
18. There will be a cash 50/50 raffle.
19. Bathroom: There is a portable bathroom on premises. Bathrooms are in the deli and pizzeria - if you purchase food from them, they should let you use their facilities – no guarantees.
20. Food Options for purchase will be available in your welcome packet.

21. All Payments Must be received by September 1st!

There will NOT be a dumpster on site. Vendors are responsible for removing all unsold items and garbage. Failure to do so will result in the loss of your security deposit and loss of eligibility for future events.
